European Governments Funding NGO "Documentation" for Lawfare Attacks

Overview

- On August 2, 2014, the Ramallah based Human Rights and International Humanitarian Law Secretariat (the "Secretariat"), a funding consortium comprised of the Netherlands, Switzerland, Sweden, and Denmark, announced "emergency funding" to nine non-governmental organizations (NGOs) for use in documenting "large scale violations of human rights and international humanitarian law the majority against Palestinian civilians and civilian objects" in Gaza.
- With this additional funding, the Secretariat is supporting "current and future documentation and investigation efforts by CSOs [civil society organizations] for the purposes of assisting and supporting national and international mechanisms" such as the UN Human Rights Council's investigation headed by William Schabas, and the campaign to open cases against Israelis in the ICC.
- The nine NGOs (Al-Dameer, B'Tselem, Badil, Breaking the Silence, DCI-Palestine, Al Mezan, Palestinian Center for Human Rights, Women's Affairs Center, Women's Affairs Technical Committee) have an extensive record of making unsubstantiated allegations of Israeli "war crimes," while disregarding clear Hamas violations. In addition, some of these NGOs played a pivotal role in providing dubious and inaccurate statements to the discredited 2009 UN Goldstone inquiry.
- None of these groups possesses the requisite military and legal expertise to
 assess potential violations of international humanitarian law. These NGOs, as
 demonstrated in their reports, do not have the capacity to address information
 pertaining to military objectives, war casualties, and other factors that are
 necessary to determine complicity in war crimes or crimes against humanity.
- In parallel to this funding, the Secretariat, together with Konrad Adenauer Stiftung, the Institute of Law and Ibrahim Abu Lughod Institute at Birzeit University, the Office of the UN High Commissioner for Human Rights (responsible for staffing and logistics of the HRC Gaza inquiry), and the "lawfare" NGO Al Haq, organized an August 19 workshop, "UN Independent Commission Inquiry to investigate violations of international humanitarian and human rights laws in the oPt."
- The emergency funding and workshop constitute additional European government support for efforts to de-legitimize Israel through "lawfare." The four Secretariat member states, which approve all calls for proposals and funding decisions per Secretariat policy (see below), bear responsibility for funding false and immoral NGO legal attacks against Israel and facilitating UN demonization frameworks.

The Secretariat - Background



- Denmark, Sweden, Switzerland, and the Netherlands jointly fund Israeli and Palestinian NGOs through The Human Rights and International Humanitarian Law Secretariat (the "Secretariat"). This funding mechanism has a projected budget of \$17.6 million over four years. The funds are managed by the Institute of Law at Birzeit University (IoL-BZU) and a European multidisciplinary consulting company, NIRAS.
- In March 2014, the Secretariat announced \$10.5 million in pooled funding, over three years, for 24 Israeli and Palestinian NGOs, including many groups that engage in legal warfare against Israeli officials and companies that do business with Israel, promote BDS (boycott, divestment, and sanctions) campaigns, advance a "1948 agenda" (rejecting a state of Israel in any form and regardless of boundaries), use explicitly antisemitic imagery and language, and exploit the false "apartheid" analogy to demonize Israel.
- The Secretariat has a focus on international humanitarian law, as seen by the emergency grants relating to the Gaza conflict. In this context, the partnership with the Institute of Law Birzeit University (IoL-BZU) is troubling:
 - In February 2014, IoL-BZU published a 15-page report, "Advocating for Palestinian Rights in conformity with International Law: Guidelines" (English and Arabic). This document advances a 1948 agenda and is a strategic manual for exploiting legal terms and rhetoric to demonize and isolate Israel internationally ("lawfare"), as well as to emphasize that Israel is among "racist regimes which are absolutely prohibited in their entirety." The extreme rhetoric advanced by the Institute suggests that it does not possess the capacity to administer the Secretariat or to carry out the objective of engaging in "policy dialogue."
- According to the Secretariat's "Fund Management Manual," calls for proposals
 and final awards must be processed by the Steering Committee of the
 Secretariat, "made up of the 'Heads of Cooperation' of the Secretariat Donors."
 As such, the emergency funding for these nine NGOs was approved by
 government officials from Denmark, Switzerland, Sweden and the Netherlands.

RE: "Emergency" funding by the Human Rights and International Humanitarian Law Secretariat

NGO Monitor has been closely following the activities of non-governmental organizations (NGOs) in response to the ongoing Israeli conflict with Hamas.

It has come to our attention that the Human Rights and International Humanitarian Law Secretariat, (based in Ramallah and Gaza) with the consent of its donor consortium (Switzerland, Sweden, the Netherlands and Denmark), will provide "emergency" funding to 9 political advocacy NGOs. According to the Secretariat's announcement, this funding will support "current and future documentation and investigation efforts by



CSOs [civil society organizations] for the purposes of assisting and supporting national and international mechanisms."

We are attaching a draft report with our research of this funding for your commentary. We are planning on publishing this report next week and thereby request your comments no later than **September 2, 2014**.

In addition, we would like to request a response to the following questions:

- 1. What are the full amounts awarded to each of the 9 recipient NGOs in the emergency framework?
- 2. Were the governments of the donor consortium involved in the decision making process to provide this funding for the declared purpose of "documentation and investigation efforts," and in the choice of NGO recipients? If yes, what was the nature of this involvement?
